Box 7011; Hines, Il 60141 This packet would be sent by Certified - Return Receipt - by the following bar code: 9101 0674 4542 9103 1334 09. November 14, 2006. This would cost \$8.63 to send to me.

The mailing package address is Exhibit A and copied over the USPO Track and Confirm, showing no record of this item. This is colored orange. The second page is the Fed Ex Track Shipment showing reference to the above number. The package label has been attached. I have received this prescription just by the USPO packaging.

Exhibit "B" is a similar example, showing the 'double billing', showing the USPO Track and Confirm Label and similar Number in Green. This one, for Oct 23, 2007 also cost \$8.63 to sent to the second Page - Fed Ex - Track Shipments, the Reference Number of the USPO packet.
